CONSENT IN TERMS OF SECTION 102 OF THE MINERAL AND PETROLEUM RESOURCES DEVELOPMENT ACT, 2002 (ACT 28 OF 2002) (HEREINAFTER REFERRED TO AS "THE SAID ACT") TO INCLUDE THE PROSPECTING RIGHT UNDER REFERENCE NUMBER 676PR OVER PORTIONS 2, 3 AND THE REMAINING EXTENT OF THE FARM KLIPBANK 296 IT AND PROSPECTING RIGHT UNDER REFERENCE NUMBER 677PR OVER PORTIONS 1, 2, AND THE REMAINING EXTENT OF THE FARM ADRIONOPLE 296 IT SITUATED IN THE MAGISTERIAL DISTRICT OF ERMELO

1. WHEREAS **Langcarel (Pty) Ltd** [Hereinafter referred to as the applicant] is the holder of a mining right, **granted by the Minister of the Department of Mineral Resources in terms of Section 23 of the Mineral and Petroleum Resources Development Act, 2002 ('MPRDA')** in respect of Coal over **Portion 1 and 9 of the farm Mooiplaats 290 IT** situated in the Magisterial District of **Ermelo/Amersfoort**.
