Environmental Impact Management Services (Edms) Bpk (EIMS) is aangestel deur Black Mountain Mining (Edms) Bpk – die Aansoeker – vir die voorbereiding en indiening van 'n Basiese evalueringsverslag (BAR) en Omgewingsbestuursprogram (EMPR), sowel as die uitvoering van 'n geïntegreerde openbare deelname proses ter ondersteuning van 'n aansoek vir 'n Prospekterreg en Omgewingsmagtiging.

Die Prospekterreg aansoek sal in ooreenstemming wees met die vereistes van die Minerale en Petroleum Hulpbron Ontwikkelings Wet (Wet 28 van 2002, soos gewysig) (MPRDA) en die gepaardgaande regulasies; asook die Nasionale Wet op Omgewingsbestuur (Wet 107 van 1998, soos gewysig) (NEMA) en die gepaardgaande regulasies, wat ingedien sal word by die Departement van Minerale Hulpbronne (DMR) Noord-Kaap.

Black Mountain Mining (Edms) Bpk, het 'n aansoek vir 'n Prospekterreg ingedien om te bepaal of ekonomiese lewensvatbare minerale bronne van Ysterhoudende en basismetale (Koper, Yster Lood, Sink, Mangaan, Nikkel en Molibdeen) en alle verwante metale en minerale. Edelmetale (gouderts, silwererts) en alle verwante metale en minerale in die aansoek area voorkom. Beide nie-indringende en indringende prospekteringstegnieke sal toegepas word. Die teiken geologiese formasie is die Boesmanland Groep.

Die Tierklip Projek Area strek oor 'n oppervlak van ongeveer 180 001 hektaar. Die voorgestelde prospektering gebied is ongeveer 100 tot 170 kilometers Suid oos van die dorp Aggeneys en 173 kilometers Suid Wes van die dorp Upinton, Namakwaland Distrik, Noord-Kaap Provinsie. Die betrokke eiendomme en plase word in die aangehegte agtergrondinligtingsdokument aangedui. Hierdie eiendomme kan verander na die aanvaarding van die Prospekterreg-aansoek deur die DMR. Indien die aansoekarea verander, sal die opgedateerde eiendomme in die konsep Basiese Evalueringsverslag voorsien word wat beskikbaar sal wees vir publieke kommentaar.

NOTIFICATION REGARDING AN APPLICATION FOR A PROSPECTING RIGHT AND ENVIRONMENTAL AUTHORISATION SEVERAL FARM PORTIONS (AREA 4- TIERKLIP) WITHIN THE NAMAKWA AND ZF MGCAWU DISTRICT MUNICIPALITY IN THE NORTHERN CAPE PROVINCE

Environmental Impact Management Services (Pty) Ltd (EIMS) has been appointed by Black Mountain Mining (Pty) Ltd – hereafter referred to as the applicant – to prepare and submit a Basic Assessment Report (BAR), Environmental Management Programme (EMPR), as well as an Integrated Interested and Affected Party (I&AP) Consultation process, in support of a prospecting right application and Environmental Authorisation.

The prospecting right application will be undertaken in accordance with the requirements of the Minerals and Petroleum Resources Development Act (Act 28 of 2002, as amended) (MPRDA) and the associated regulations, and the National Environmental Management Act (Act 107 of 1998, as amended) (NEMA) and the associated regulations, and has been lodged at the Department of Mineral Resources (DMR) – Northern Cape.

The applicant, Black Mountain Mining (Pty) Ltd, is applying for a prospecting right application in order to ascertain if economically viable mineral deposits exist within the application area for the following: Ferrous & base metals (Copper, Iron, Lead, Zinc, Manganese, Nickel, Molybdenum) and all associated metals and minerals, precious metals (Gold, Silver) and all associated metals and minerals. Both non-invasive and invasive prospecting techniques will be utilized.

The Tierklip Application Area covers an area of about 180 001 hectares. The area is located approximately 100 to 170 kilometres South East of the town of Aggeneys and 173 kilometres South West of the town of Upington, Namaqualand District, Northern Cape Province. The affected farm portions are provided in the attached background information document. It should be noted that these properties may change after acceptance of the Prospecting Right Applications by the DMR. Should the application area change, the updated properties will be provided in the draft Basic Assessment Report which will be available for public comment.

The application for a prospecting right and environmental authorisation process will be carried out as stipulated in Section 16 of the MPRDA and Chapter 4 of the Environmental Impact Assessment (EIA) Regulations, 2014 (GNR 326) promulgated under the NEMA. A public notification and involvement process is being carried out as part of the process.

This notice is in accordance with clause 16 of the MPRDA and Chapter 6 of EIA Regulations, 2014, which requires that Black Mountain Mining (Pty) Ltd notify in writing and consult with the land owner or lawful occupier and any other affected party. In this regard, **we would like to ask the landowners to please notify their respective property occupiers about the proposed development or send us the occupiers' contact details so that we may notify them and include them in the Public Participation Process for this project.** The results of the consultation will be included in the BAR submission in order for the DMR to adjudicate on the application.

Interested and Affected Parties (I&AP's) are provided an opportunity to register and comment on the proposed activity and application. PROJEK INLEIDING:

Environmental Impact Management Services (Edms) Bpk (EIMS), 'n onafhanklike omgewings konsultasie firma, is aangestel deur Black Mountain Mining (Edms) Bpk (die aansoeker), om te assisteer met die voorbereiding en indiening van 'n omgewingsmagtigings aansoek, 'n basiese evalueringsverslag (BAR) en omgewingsbestuursprogram (EMPR), asook die uitvoering van 'n openbare deelname proses, ter ondersteuning van 'n aansoek vir 'n prospekterreg.

LIGGING, SKAAL EN OMVANG VAN DIE VOORGESTELDE PROJEC:

PROJEK BESKRYWING:






Figure 1: Locality Map
